

## **Terms and conditions for attendees of Dotnetos Conference 2020**

### **I. General provisions**

1. The Organizer of the Event is Dotnetos sp. z o.o..
2. The Ordering Party is a natural person or a legal entity that orders services using the <https://evenea.pl/event/dotnetos2020/> link.
3. The Terms and Conditions apply to all attendees and speakers.

### **II. Event admission**

1. The joint completion of the following steps entitles the Ordering Party to have admission to the Event:
  - a. Filling out the registration form available at <https://evenea.pl/event/dotnetos2020/>.
  - b. Sending by the Organizer the the ticket and the receipt to the e-mail address provided by Ordering Party.
  - c. Transferring the payment as defined in item IV of the Terms and Conditions.
  - d. Receiving the payment as specified in item means closing the contractual agreement between the Ordering Party and the Organizer.

### **III. Terms and Conditions of the Event**

1. Dotnetos Conference 2020 will take place on 1- 2 October 2020 in Warsaw Marriott Hotel in Warsaw, al. Jerozolimskie 65/79, 00-697 Warszawa, Poland.
2. The information about the Event fees is given on the Event website and in the Registration Form. The fee covers exclusively the items specified in the Event description published on the website.
3. Event fee depends on registration date. The day of purchasing the ticket is the day in relation to which the fee is fixed as final.
4. Registration after the end of the sale (which is 2 October 2020) may be approved on the individual acceptance of the Organizer.
5. The Organizer will have the right to end the registration earlier than announced.
6. The Organizer will have the right to set the Event schedule and to change the said schedule, even on the day when the Event takes place; in particular, the Organizer will have the right to change the timetable and the order of presentations.
7. The Ordering Party will be held responsible for any damages done within the venue premises by themselves or their representatives chosen by themselves to attend the Event.
8. The Organizer will not be held liable for any belongings of the Ordering Party or of the representatives chosen by themselves to attend the Event, which may be lost, damaged or stolen during the Event.
9. The Ordering Party agrees to comply with the safety rules, including but not limited to the fire safety rules, and also agrees to follow the instructions and orders regarding the organizational and technical issues, given by the Organizer's representatives.
10. By taking part in the Dotnetos Conference you grant the event organisers full rights to use the images resulting from the photography or video filming, taken by the staff appointed by management of Dotnetos sp. z o.o . This might include the right to use

them in printed and online publicity, as well as in social media. If you do not wish to be photographed please inform us.

11. Dotnetos sp. z o.o. can not take responsibility for allergens contained in food and drink provided at The Conference. If an attendee is sensitive to certain allergens, it is the attendees' responsibility to make sure it will not hurt them.

#### **IV. Terms and Conditions of payment**

1. The advance payment is 100% of the Event fee, unless the Parties agree otherwise. The payment should be made within the period stated in the proforma invoice, in 14 days after registration, but not later than 1 October 2020. If the payment is not credited to the Organizer's bank account within the set date, the registration will be cancelled, unless the Ordering Party contacts Organizer in order to negotiate other payment terms.
2. The Organizer will issue a VAT invoice for the Ordering Party within seven (7) days since the receipt of the payment.
3. The Organizer will send electronic invoices to the email addresses of the person making the registration in the name of the group and all the registered attendees. Valid e-mail addresses should be given by the Ordering Party.
4. The given fees are net prices and will be increased by VAT (23%).
5. The special Event fees apply only to Ordering Parties encompassed by special deal.
6. Payments made by credit card or PayPal incur a transaction fee: 2,8% or 3%.

#### **V. Substitution and cancellation policy**

1. In the exceptional cases, the Ordering Party that wishes to cancel their attendance in the Event will submit a befitting, proper e-mail message to [contact@dotnetos.org](mailto:contact@dotnetos.org). The Organizer will confirm the receipt of the said statement through e-mail to the address given in the registration form. In such a situation, with respect to the rules described below, the paid Event fee will be transferred back to a bank account indicated by the Ordering Party.
2. Tickets sold at Blind Bird and Early Bird price, as well as any tickets sold with a discount, are non-refundable.
3. Tickets sold at Normal and Angry Bird prices are refundable up to thirty (30) days before the Event for a handling fee of 100 PLN/25 EUR per attendee. Tickets are non-refundable less than thirty (30) days before the Event.
4. The Ordering Party will have the right to substitute an attendee up to 1 week before the Event. In this case the paid Event fee will not be returned.
5. In case of non-appearance of an attendee at the event, the Ordering Party will bear the event fee in full.

## **VI. Changes in schedule and participation fees**

1. The Organizer has the right to extend the registration period and to change the Event fee payment schedule.
2. The Organizer has the right to close the registration when the number of registered attendees exceeds the capacity of the Conference venue.
3. The Organizer will have the right to decrease the fees for specific groups of attendees.

## **VII. Event cancellation**

1. The Organizer will make every effort to maintain the quality of the Event as specified in its description.
2. The Organizer will have the right to cancel the Event if uncontrollable circumstances occur. All the fees paid by the Ordering Party will be reimbursed then in full by the Organizer.
3. Uncontrolled circumstances include, but are not limited to:
  - a. floods,
  - b. fires within the venue premises,
  - c. war or hostilities,
  - d. failure within the venue premises, including but not limited to a failure in the following systems: electrical installation, water and sewerage, gas installation, heating, air-conditioning, fire-protection or any other whose occurrence poses a threat to the safety and health of the attendees staying within the premises,
  - e. riot, commotion,
  - f. road, air or railroad disaster that makes both the access to the venue and the safe course of the Event impossible ,
  - g. any other event whose occurrence makes carrying out the Event as planned impossible or that poses a threat to the safety and health of the attendees .
4. In the widest scope permitted by the laws of the Republic of Poland the Organizer will not be held liable for any damages suffered by the attendees in relation to the organizing, carrying out, cancelling or postponing of the Event.
5. The Organizer will not be held liable for any benefits lost due to the said changes. In the event of the concurrence of contractual liability and general liability, an attendee may claim damages within the aforesaid limits, exclusively under the provisions herein.

## **VIII. Code of conduct**

1. All attendees, speakers, sponsors and volunteers at our conference are required to agree with the following code of conduct. Organisers will enforce this code throughout the event. We expect cooperation from all participants to help ensure a safe environment for everybody.
2. Our conference is dedicated to providing a harassment-free conference experience for everyone, regardless of gender, gender identity and expression, age, sexual orientation, disability, physical appearance, body size, race, ethnicity, religion (or lack thereof), or technology choices. We do not tolerate harassment of conference participants in any form. Conference participants violating these rules may be sanctioned or expelled from

the conference without a refund at the discretion of the conference organisers. If you are being harassed, notice that someone else is being harassed, or have any other concerns, please contact a member of our conference staff—they can be identified as they'll be wearing branded clothing and/or badges.

3. Conference staff will be happy to help participants contact hotel/venue security or local law enforcement, provide escorts, or otherwise assist those experiencing harassment to feel safe for the duration of the conference. We value your attendance.
4. We expect participants to follow these rules at conference and workshop venues and conference-related social events.

## **IX. Final provisions**

1. Additional provisions regarding the Event Attendees:
  - a. By registering for the Event the Ordering Party enters into the contractual agreement to attend the Event and agrees to these Terms and Conditions, which form an integral part thereof.
